**TERMS & CONDITIONS**

**General:**

- Wedding Package quote valid for 2 weeks only.
- 100 KM total travel (from Cape Town CBD) is included with all packages. Thereafter R4.50 will be charged per KM.
- A table must be set and provided for the Westside Studio Photography &/or Film team, the same as the guests table and setting. (1 hour overtime is charged if table setting and meals are not provided)
- Changes: It is the client's sole responsibility to inform Westside Studio Photography and Films of any specific needs or changes in events.
- Westside Studio Photography and Films shall be the sole professional photographer and film team at the venue specified.
- Failure: In the unlikely event of total photographic &/or film failure the Photographer(s) liability shall be limited to a full refund of all money paid.
- Delivery: Please allow 6-8 weeks for post production of photographs &/or films. Albums and books can take 8 - 12 weeks.
- Collection: Final product to be collected at our studio (Amalgamated House, 78 Jordaan Street, Cape Town, 8001)
- Courier Services: All delivery and courier services at extra cost.

**On the wedding day:**

- Sole Rights: The Photographer &/or Film Team shall be the sole professional Photographer(s) at the venues specified.
- No objection is made to family taking photos at the event, providing due priority is given to the professional Photographer(s) to ensure proper discharge of this Contract.
- Requested Photographs and Video: The photographer(s) will honour all photographs &/or film footage requested and agreed in advance, provided the following factors are met: weather and allocated time permitting, availability and co-operation of the person(s) concerned.
- Coverage: The Photographer(s) cannot be held responsible for the lack of coverage caused by the bride, the groom, or wedding party not being on time, or by Church, Register Office, or Licensed place of wedding restrictions on photography. The Photographer(s) do not undertake to guarantee any specific picture nor incorporate any specific background, location or group arrangement.
- Weather Changes: Weather permitting, the wedding photographs &/or film footage will be taken as agreed. In the event of rain or snow or any form of weather disturbance, the photographer(s) will make the necessary changes in the photographic &/or filming session(s) and will not be responsible for any disappointment caused by the weather. However, the photographer(s) with the cooperation of the client will do his best to produce coverage of the wedding within the time allocated to him or them.
- Over Time: Over time charged at R1000 per hour. (for the photographic and film team, respectively)

**Booking fee & Final Payment**

- Secure date: No date will be booked unless a 50% deposit is paid. The deposit is non refundable and non exchangeable for any other products or services. (In other words, if the client changes their date and Westside Studio is not available for the new date, the client will lose their deposit)
- A non refundable second payment of 50% of the package(s) is due two weeks prior to the event.
